I am emailing today to alert you to the implementation this past weekend of a new law prohibiting texting or talking on a cell phone without a hands-free device while driving and upcoming timelines for Open Enrollment for Medicare.

Texting or talking on a cell phone while driving

On Saturday, October 1, a new law went into effect prohibiting texting or talking on a cellular without a hands-free device while driving. Law enforcement will issue a verbal or written warning for these violations until the end of the year. Beginning January 1, 2012, violations will result in graduated fines. Important Information for Owners of Classic Cars

If you own a classic car, street rod, classic rod or old timer vehicle, a new law took effect on October 1 that exempts these vehicles from emission inspections if they were not driven more than 5000 miles in the previous year. I sponsored this legislation, AB 2, at the request of a constituent.

Owners of these vehicles will need to fill out a form and pay a fee that equals the cost of complying with the emission standards. If you have any questions about this legislation, please feel free to contact me.

Important News for Medicare-Eligible Seniors

The Open Enrollment period to review and change Medicare coverage is **October 15-- December 7, 2011**. This year's Open Enrollment period starts earlier and lasts longer.
